Agreement

This Agreement dated _____ is made between Breen & Emma Hofmann, dba Lazy "H" Ranch (hereinafter referred to as "Operator") and _____, (hereinafter referred to as Owner).

The Operator will provide the normal and reasonable care to maintain the health and well-being of the animal. Owner is required to worm their horse(s) on a regular basis, assure their horse(s) receives annual vaccinations, and provide proper hoof trim and shoeing.

Emergency Care

Operator agrees to attempt to contact Owner should Operator feel that medical treatment is needed for said horse(s), but if Operator is unable to contact Owner, Operator is then authorized to secure emergency veterinary and farrier care required for the health and well being of said horse(s). All costs of such care

shall be paid to Owner, and Operator is hereby authorized to arrange direct billing to Owner. In the event of an emergency Owner may place a \$ _____ cap on veterinary or farrier care until the Owner can be reached.

Risk of Loss & Hold Harmless

It is agreed that during the term of this Agreement the risk of loss shall be assumed by Owner in the event of loss or injury to the said horse(s) and _____ agrees to hold Breen & Emma Hofmann dba The Lazy “H” Ranch , harmless from such loss or injury.

Owner is responsible for full and complete insurance coverage on said horse(s) and personal property. Owner agrees Breen & Emma Hofmann dba The Lazy “H” Ranch is not liable for damages of any kind including but not limited to damages which arise out of or in connection with boarding of said horse(s), whether or not such damages are caused by fire, theft, the running away, behavior or act of said horse(s) or any other cause whether the said horse(s) be on the premises of the The Lazy “H” Ranch or not.

Termination

Owner may terminate this Agreement with 30 day notice to the Operator. A lack of 30 day notice by the Owner will result in full payment of 30 day boarding rate. Breen & Emma Hofmann dba The Lazy “H” Ranch may terminate this Agreement with 30 day notice and reserve the right to terminate without notice when deemed necessary.
